

THINK TANK DEVELOPMENT OF A NATIONAL/REGIONAL MODEL FOR MANAGING LITIGATION

You work in the Office of the General Counsel for a public company which has been growing rapidly both in terms of revenues and additional offices nationwide. The company has long-standing relationships with law firms for its corporate, securities, and tax work. The draft RFP and plan must be delivered to the General Counsel in one week. Where do you start, and what issues are likely to be of primary concern to you in preparing the draft RFP and the plan?
