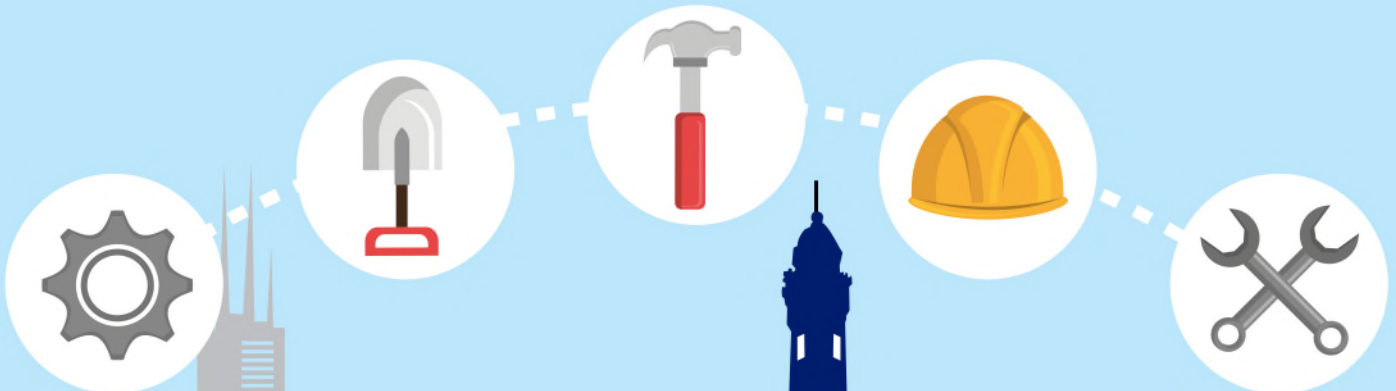

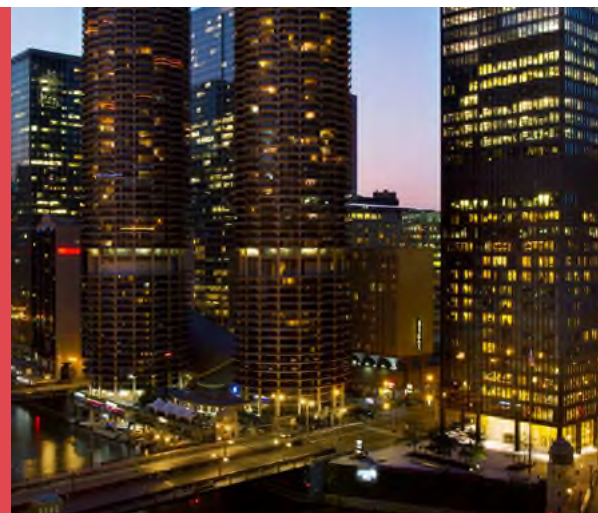

**SEGMENT THREE: Erecting Solid Framing—
Winning the Case Before
You Get to the Merits**


This segment will focus on the commencement of litigation, and specifically the critical early choices on where and how to get disputes resolved in the most efficient and effective way possible. Often early decisions must be made that could dramatically impact the timing, duration, cost, and even substantive outcome of disputes. These choices include the possibility of early mediation, the option of arbitration, and court venue decisions including state v. federal court and the location of the litigation. The pros and cons of the various options, including considerations of confidentiality, timing, costs, rights of appeal, and the need for injunctive relief, will be explored and discussed in depth by the panel of both international litigation counsel and in-house litigation and transactional counsel.
